- 1. Only AVPA members up to date with their annual membership may register for the AVPA contest.
- 2. The Member acknowledges and accords the right to the association to mention his/her name and the results of the competition, by any appropriate media support of his/her choice (website, catalog, data sheets, etc.)
- 3. The producer delivers on time a representative set of:
 - -4 sale units (4 x 250 g. or 4 x 1/2 lb minimum) of each coffee concerned (only coffee beans).
 - The producer will be responsible for their proper delivery to the main office of the Association.
- 4. After the release of the results, the signed diplomas will be sent by email and the original given to laureates who will be present at the headquarters of the Association or will be sent by courier to the winners (courier cost for winners account)
- 5. If he is awarded, the producer will have the obligation to put on its packaging a replica of the medal under the AVPA license contract and after having signed this license before using the said distinction.

6. At the end of the competition the awarded winners accord the right to AVPA to make the best use of their information and of their products, especially in the context of AVPA's events and training periods and are committed to participate in the association promotion effort.

To do this, they will send to AVPA as soon as possible the following items:

- All information and pictures necessary for the edition of a producer and a product presentation sheet.
- For each awarded coffee a number of gift coffee packages (ground coffee for direct brewing and coffee beans for espresso) as per the following:
 - Estate Coffee: 20 packages
 - Other professional: 50 packages
 - Organization Coffees: 20 packages per member of the organization.
